Only licensed technicians are allowed to prepare and discharge such effects, and such effects shall remain as demonstrated and licensed for every performance. If the application to **CREATEHK** is refused, the pyrotechnics will not be presented on stage.

We will monitor the action closely, and ensure it remains faithful to the intent stated below. We will undertake all responsibility of any damage or cleaning necessary from such action.
